SECTION 4 : FIRST AID MEASURES

Keep away from extreme heat and from freezing conditions and away from all sources of ignition. Make sure the material does not come into contact with substances listed as: "Materials to Avoid".

EYES PROTECTION : The use of safety glasses is recommended. If a material is to be handled in a manner where splashing may occur, the use of splash goggles or face shield is recommended.
